Petition Information	<ul style="list-style-type: none"> DS-DE 104 Candidate Petition is the petition format prescribed by the Division of Elections and shall be used by the candidate to reproduce petitions for circulation <i>(FS 99.061, 99.095, 99.096)</i> Before noon, May 14, 2024: All petitions for verification must be submitted to the Supervisor of Elections office <i>(FS 99.061, 99.095, 99.096, 99.097)</i> The SOE shall be paid in advance the sum of \$0.10 for each signature required to be verified <i>(FS 99.097)</i> If a candidate cannot pay such charges without imposing an undue burden on personal resources or on the resources otherwise available to the candidate, an Affidavit of Undue Burden may be filed with the Supervisor of Elections to have the signatures verified at no charge <i>(FS 99.097)</i> Prior to disposing of surplus funds in the campaign account, a candidate (excluding a write-in candidate) who qualified by the petition process and filed an Affidavit of Undue Burden to waive the petition signature verification fee, must reimburse the SOE the amount of the waived fee <i>(FS 106.141)</i>
