

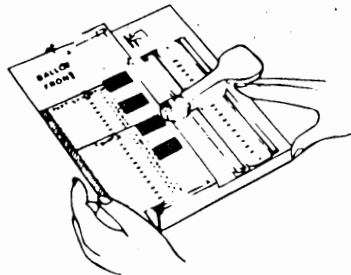
# SAMPLE BALLOT

### INSTRUCTIONS TO VOTER: HOW TO VOTE YOUR BALLOT CARD

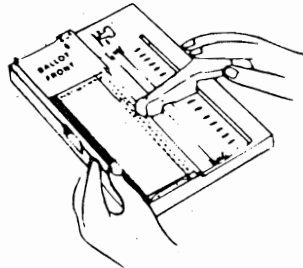
#### STEP 1

Vote only one ballot card at a time. Slip ballot all the way into tray, UNDER clear plastic cover from left side of machine.



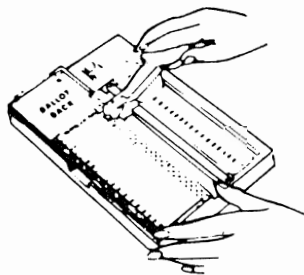
#### STEP 2

Move the chrome punch lever so the red pointer is to the right of the candidate of your choice. Depress the lever which will punch out the cross + in the voting square to the right of the candidate's name. To vote on any proposition appearing on the ballot, PUNCH OUT THE CROSS + in the voting square to the right of the words "FOR" or "AGAINST".



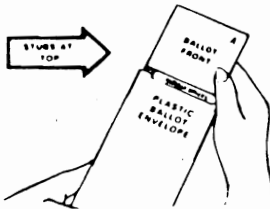
#### STEP 3

Repeat Step 2 with each remaining ballot card. All distinguishing marks or erasures are forbidden and make the ballot void. If you make a mistake, tear or deface any portion of your ballot card, replace the card in the plastic ballot envelope and return to the election official for another ballot.



#### STEP 4

After you have completed voting, turn the punch head to the top position. Place your ballot card(s) in the plastic envelope with the numbered stub(s) at the top and hand it to the election official, who shall then in the presence of the voter, remove the numbered stub(s). The voter may then personally deposit the voided

PROPOSED CHARTER LAW AMENDMENT		
AMENDMENT RELATING TO PAVING AND CONSTRUCTION OF RECREATION FACILITIES WITHIN THE HOGTOWN CREEK WATERSHED AREA		
Amends the Charter to prohibit the City from constructing any paved surface for transportation or recreation facilities (examples: sidewalks, trails, parking lots, tennis courts, pools), and may prohibit constructing any unpaved recreation facilities (example: playgrounds) on recreation and conservation lands within the Hogtown Creek Watershed (generally the western half of the city). This amendment refers to a nonexistent plan, but may mean the current Comprehensive Plan; and makes the Comprehensive Plan inconsistent with the Charter.

"THE CITY OF GAINESVILLE, FLORIDA, WILL NOT EXPEND, USE NOR SEEK, ANY CITY, COUNTY, STATE OR FEDERAL FUNDS FOR THE CONSTRUCTION OF ANY PAVED SURFACE FOR TRANSPORTATION USE OR RECREATIONAL FACILITY IN THE AREA DESIGNATED UNDER THE CITY OF GAINESVILLE COMPREHENSIVE PLAN, 1990, FOR RECREATIONAL USE OR CONSERVATION USE IN THE HOGTOWN CREEK WATERSHED FROM THE DATE OF THE ADOPTION OF THIS CHARTER AMENDMENT."
