

## **BECOME AN ELECTION WORKER**

Join our special group of civic-minded citizens who are trained and ready to perform a **paid**, valuable community service by assisting voters at the early voting sites and at the polling places on **Election Day**.

If you are interested, call our office or apply on our website (**VoteAlachua.gov**).

Requirements: Be a **citizen** of the United States; **registered** to vote in Alachua County; able to speak, read, and write in **English**; have **transportation** to the polls; able to work from 6 a.m. until after the polls close at 7 p.m. on Election Day.

### **VOTING IN PRIMARY ELECTIONS**

Florida is a **Closed Primary State**. In Primary Elections, you may only vote for the candidates of the political party with which you are registered. Party changes must be submitted no later than **29 days** prior to the Primary Elections.

## **2024 ELECTION DATES**

March 19, 2024: Presidential Preference Primary

Last day to register to vote or change party affiliation: February 20, 2024

#### August 20, 2024: Primary Election

Last day to register to vote or change party affiliation: July 22, 2024

#### November 5, 2024: General Election

Last day to register to vote: October 7, 2024

## WAYS TO VOTE

- Vote by Mail
- Vote Early at an Early Voting Location
- Vote at Your Precinct

Florida law requires that you be registered to vote at least 29 days prior to an election.

## WHAT TO BRING TO THE POLLS

You are required to present picture and signature identification before voting. A Florida Driver's License, a Florida ID card, a U.S. Passport, debit or credit card, military or student ID, retirement center or neighborhood association ID, public assistance ID, Veterans Health ID card, concealed weapons license, or government employee ID will be accepted by election officials.

You may use **two forms of identification, one with a signature and one with a photo,** to meet this requirement. If you do not present proper identification, you will be required to vote on a provisional ballot.
